### The Policy:

#### Medical Equipment

Portable medical equipment is automatically covered anywhere within the UK.

#### Business Interruption

To cover additional expenses incurred following damage at your own premises.

#### Liability

Generally, Brokers offer a standard office or surgery policy, but this may not provide adequate protection. The Brett&Randall policy automatically includes cover for employees working on clients' premises, in mobile units or anywhere else within the UK.

#### Malpractice

For the company, not the individual Doctor or Nurse.

#### Professional Indemnity

To protect the Company against non clinical errors or omissions.

#### Mobile Units

The policy can be extended to cover mobile units and their fittings.

#### Property

Covers all office contents against accidental damage or theft.
